From Mr Tunks enclosing copy correspondence with Minister of Lands with references to the general cemetery reserved in this municipality for the district of St Leonards and suggesting that application be made to the Government to fence it in, and requesting to be informed whether this Council are willing to become trustees and co-operate with the other councils St Leonards and St Leonards East as regards the lands not allotted to religious denominations so as to secure a burying place to those not influenced by episcopal authority to contribute mortuary gifts or fees. Payment of account amounting to the sum of £112-5-4 was authorised – On the motion of the Mayor, the following Resolution was passed – That the sum of £46-11-0 having been subscribed and paid over to this council by the treasurer of the Flat Rock Bridge Committee, this council orders that the sum of £93-2-0 be expended on the said work under the direction of the said committee and for this purpose this amount, together with the sum payable by the Government for the like purpose when received be paid over to the Flat Rock Bridge Committee Messrs Bligh, Broadfoot and French. Carried unanimously. The Mayor asking for authority to expend a sum not exceeding £3 in filling up ruts and carting gravel on road from Frenchs Road to end of Frenchs fence towards Sailors Bay. Ayes The Mayor, Alderman French and Bryson. Noes Alderman Broadfoot, Russell and Pollard. The Mayor declined to give his casting vote. The Mayor asking the Council to decide on what steps should be taken for the recovery of certain arrears of rates. He stated what had been done but as some of those in arrears were beyond the jurisdiction of the Sydney District Court he was desirous of having the authority of the Council before taking them into another court. 5<sup>th</sup>. A petition from the council to His Excellency the Governor-General praying that the borough be divided into two wards.

Proposed by the Mayor – That a working overseer be appointed at such rate remuneration as may be determined by the council. Withdrawn.

Proposed by Alderman French – That a road one chain wide be made between Rennard's and Taylor's land. And that the former motion referring to this line of road be rescinded. To stand over until next meeting to allow Alderman French, Pollard and Broadfoot to examine it.

Proposed by Alderman Broadfoot that this council is not willing to become co-trustees with St Leonards for the public burial ground. Carried.

Proposed by the Mayor – That the road opposite Parkers be formed so as to make it passable to the public. Ayes the Mayor and Alderman Bryson. Noes Alderman Russell, Broadfoot and Pollard.

Proposed by Alderman Broadfoot – That the petition read be adopted and steps taken to carry out the same. Ayes the Mayor, Alderman Bryson, French, Pollard and Broadfoot. Noes Alderman Russell.

Proposed by the Mayor – That the line of road as surveyed by Mr Surveyor Woolrych be adopted. Amendment by Alderman French – That the road is not paid out in the best place

and be not sanctioned. Original motion Carried. Ayes the Mayor, Alderman Russell and Broadfoot. Noes Alderman French.

Proposed by Alderman French – That a sum of £30 be voted for putting up a culvert and filling in approaches on French's Road near Adamson's. Ayes the Mayor, Alderman French and Bryson. Noes Alderman Broadfoot, Russell and Pollard. The Mayor gave his casting vote with the Ayes.

Proposed by Alderman French – That a sum of £10 be voted for putting up stone posts at corners of municipality reserve. It was moved by Alderman Russell – That the hill be cut down at the junction of the Greenwich five chains long 4 feet 6 inches deep at the crown of the hill half chain wide the water tables to be 18 inches lower than the crown of the road and the banks to be nicely formed. Carried. By Alderman Russell – That Michael Power be authorised to form two chains more on the Lane Cove Road opposite Parkers at one pound per chain. Carried. By Alderman Russell – That Michael Power be paid one pound for stumping portion of the Lane Cove Road in his former contract. Carried. By Alderman Russell – That 300 tons of iron stone be laid on the Lane Cove Road. Subsequently reduced to 200 and carried. By Alderman Russell – That the Government Road from the Lane Cove Road to the Roman Catholic burial ground be stumped and cleared. Carried. By Alderman Russell – That the Council take steps to employ a competent person as Surveyor Clerk and Collector at an annual rate. Withdrawn. By Alderman Russell – That the Mayor be instructed to write to the Committee of the School at North Sydney to ascertain whether the Council meetings could be held there at certain hours. Withdrawn. By Alderman Russell – that the Mayor be instructed to call the Government attention to the Greenwich Road. Carried. It was moved by Alderman Bryson – That 100 tons of screen gravel be put on the Lane Cove Road between R Greens and Mr Bryson to stand over until the committee inspect it.

The three following motions standing in the name of Alderman Bryson were withdrawn. That Alderman French's Notice of Motion be carried out to clear the road to the Catholic burial ground. That tenders be called for cutting down Gores Hill 5 feet deep on the crown of the hill and half chain wide the water tables to be 18 inches lower than the crown of the road the stuff to be put at the bottom of the hill to fill up that hollow. That a committee be appointed to inspect Berry's Little Hill and to report upon it. It was moved by Alderman Pollard – That no steps be taken to remove encroachments on the road in front of Janes property remain until the present fence falls down or removed. Withdrawn by Alderman Pollard – That the Council take into consideration the line of road through Woolland land withdrawn.

The following motions standing in the name of Alderman Broadfoot were drawn. If expedient the lowest tender for clearing and stumping the road leading from Burns Bay Road to the tannery be accepted. If not fresh tenders be called for same. That the Mayor be requested to apply to the Government for a deviation of aforesaid road. The following correspondence was read and laid on the table - from Register General calling for a return of receipts and disbursements for municipality year ending 31 January 1870 – from Lands Department stating that Dr Taylor's written consent must be forwarded before road could be made through his land – for written consent of parties through whose land proposed road to Mowbray point would pass – declining to alter road at Flat Rock Creek – asking for written consent of parties through whose land proposed road from Sydney Street through Jarmans and other properties applied to be laid out enclosing tracing showing boundaries and means of access to burial ground. The tenders were then taken into consideration – with reference to those for clearing road to burial ground it appearing the Government had forwarded plan of Government burial ground whereas the motion referred to was the Roman Catholic burial ground given by the late Mr Lithgow – consequently the tenders could not be considered.

On the motion of Alderman Broadfoot – that Wallace and Donnelly's tender be accepted for work on the Greenwich Road – Alderman Bryson and French objected stating as their reason that a resolution had been passed that no money should be laid out on any roads until proclaimed and that there were other portions of the road requiring to be done more than that portion under consideration. Language of a very violent nature having been used towards each other by Alderman Russell and Bryson the Mayor left the Chair.
